**Prerequisites:** MATH 2001 (Introduction to Discrete Mathematics), or equivalent. In particular, you should be familiar with finite sets, mathematical induction, the pigeonhole principle, equivalence relations, and partial orders just to name a few things, as well as have experience with proving mathematical statements.

Text: Steven R. Lay, Analysis - With an Introduction to Proof, 5th edition, Pearson, 2014.

**Course Outline:** Analysis I is a course in which the student goes back to single variable calculus, and learns the rigorous theory behind it. In particular, we will cover the topology and structure of the real line, sequences of real numbers, limits and continuity, differentiation, the Riemann integral, as well as the proofs of important theorems such as the Intermediate Value Theorem, the Mean Value Theorem, Taylor's Theorem, and the Fundamental Theorem of Calculus.

**Homework Assignments:** There will be weekly written homework assignments due (almost) every Wednesday. There will be 13 total, and the best 10 will be counted toward 20% of your final grade. You are encouraged to work on the homework assignments together, but each student must submit their own work in their own words.

Midterms: This course has two midterm exams and a final exam. Calculators and cell phones will not be allowed during any portion of any exam. Use of any electronic device at any time during the exam will be considered cheating. There will be no makeup exams given under any circumstances except for those described in the policies outlines below, so make sure that you have no conflicts.

- Midterm 1: Friday, September 23, held in class.
- Midterm 2: Friday, November 4, held in class.

Final Exam: The final exam for the course is cumulative. It is scheduled for:
